1. **CALL TO ORDER:** The closed meeting of the Board of Directors of the Monterey Fire Safe Council was called to order by Chairperson Stefani at 11 AM. Since the membership had requested that this meeting be closed and non-board members would be excused, Agenda item #6 © was re-scheduled for immediate attention.

Board Members absent: Steve Davis (USFS), Mike Chiodini (BLM ), Miguel Errea (MCA), Chuck Winge.(Treasurer)

3. **REVIEW OF MINUTES:** Minutes from the December 30, 2006 Regular Board meeting were distributed and reviewed.

**Correction** – Bob Sayre is resubmitting to the FSC Grant Clearing House a form of the WWUI grant. Also **Danny Marquis was present at the November meeting.**

4. **CORRESPONDENCE:** The Board is informed that CDF is now known as CalFire.

5. **TREASURER'S REPORT:** In the absence of the Treasurer the Financial Status of January 25, 2007 was distributed. .

Since Grant #6 has \$4,513.47 remaining Bob Sayre rescinds the suggestion he made at the Steering Committee meeting (#4 Old Business).

Review and authorization of invoices: The Board approved the four checks written by Treasurer Winge.

- b. Paid from Administration funds: Sandy Rose Insurance \$680.00, Monterey Bay Internet \$15.00, Webmaster Gianni Grassi - \$250.00. It was noted that although the Board, by e-mail, had approved payment of the Secretary's invoice for \$312.00 there was no check written.
